## State Bank of India cuts FD rates by 20 basis points across tenors from May 16

**Mumbai:** State Bank of India (SBI), the country's largest lender, has cut fixed deposit rates by 20 basis points across tenors effective May 16.

According to the bank's website, the cut in interest rates on retail domestic term deposits below ₹3 crore is applicable for both the general public and senior citizens.

Deposits for two years to less than 3 years will offer the maximum interest to investors at 6.7 per cent, followed by three years to less than five years which will give a 6.55 per cent interest from May 16. Fixed deposits of five years to 10 years now get an interest of 6.30 per cent for the general public, while it is 6.5 per cent for deposits of duration one year to less than two years.

The interest rate of the specific tenor scheme of "Amrit Vrishti"(444 days) has also been revised from 7.05 per



cent to 6.85 per cent, effective May 16, 2025. Senior citizens and super senior citizens (aged above 80 years) are eligible for their additional benefits in the rate of interest. Last month also, SBI had cut deposit rates by 10-25 basis points, taking a cue from the policy rate cuts by the RBI.

The Reserve Bank in April had slashed key interest rate by 25 basis points for the second time in a row to support growth facing the threat of reciprocal tariffs by the US. The policy repo rate now stands at 6 per cent. Shares of SBI were trading at ₹793.95, up 0.27 per cent over the previous close on the BSE.(PTI)

### Suzuki Motorcycle India to manufacture 7.5 lakh vehicles at new Rs 1,200 crore plant

**New Delhi:** Suzuki Motorcycle India Pvt Ltd (SMIPL) on Tuesday laid the foundation stone for its new manufacturing plant in Haryana, with an initial investment of nearly Rs 1,200 crore and an annual production capacity of 7.5 lakh units in the first phase. Located at IMT Kharkhoda -- an industrial township developed by Haryana State Industrial and Infrastructure Devel-

opment Corporation (HSI-IDC) -- the facility aligns with the government's vision to boost industrial infrastructure, attract global investments and generate employment in the region. The plant is scheduled to



commence operations in 2027, further boosting SMIPL's production capabilities in India. Once functional, it will provide employment to around 2,000 people, said the company in a statement. Kenichi Umeda, Managing Director, SMIPL, said that laying the foundation stone for their second plant in India, "reflects our focus on not just growing as a brand, but to grow with the people and communities of India".

By establishing our facility at IMT Kharkhoda, we look forward to contributing to the region's development, generating employment, and supporting the government's vision for industrial progress, he mentioned. It will also feature modern automation and energy-efficient systems, helping us move towards Suzuki's global vision for carbon neutrality and Sustainability.

The facility is spread across 100 acres, with the manufacturing unit initially covering 25 acres and an additional 25 acres dedicated to green space, reflecting the company's increasing focus on sustainable growth. SMIPL started its India operations in February 2006 from its manufacturing plant at Kherki Daula, Gurugram. The company currently manufactures scooters (125cc), premium motorcycles (150cc and above) and the big bikes best suited for the Indian customers.

## Stock markets bounce back on buying in bank stocks; Sensex jumps over 800 points

**Mumbai:** Stock market benchmark indices Sensex and Nifty rebounded sharply in morning trade on Wednesday after heavy drubbing in the previous session amid buying in blue-chip bank stocks and a firm trend in Asian peers.

The 30-share BSE benchmark gauge Sensex bounced back in early trade and later jumped 835.2 points or 1.02 per cent to 82,021.64. The NSE Nifty surged 262.3 points or 1.06 per cent to 24,946.20.

From the Sensex firms, Sun Pharma, Bajaj Finance, UltraTech Cement, Mahindra & Mahindra, Bajaj Finserv, Tech Mahindra, HDFC Bank and Tata Motors were the biggest gainers. IndusInd Bank emerged as the only laggard. Moody's Ratings said on Wednesday, India is well-positioned to deal with the negative effects of US tariffs and global trade disruptions as domestic growth drivers and low dependence on exports anchor the economy.

In a note on India, the agency said government initiatives to boost private consumption, expand manufacturing capacity and increase infrastructure spending will help offset the weakening outlook for global demand.

In Asian markets, South Korea's Kospi, Shanghai's SSE Composite index and Hong Kong's Hang Seng were trading in the positive territory while Japan's Nikkei 225 index quoted lower.



US markets ended lower on Tuesday.

Global oil benchmark Brent crude jumped 1.62 per cent to USD 66.44 a barrel. Foreign Institutional Investors (FIIs) offloaded equities worth Rs 10,016.10 crore on Tuesday, according

to exchange data.

Retreating from early highs, the 30-share BSE Sensex tanked 872.98 points or 1.06 per cent to settle at 81,186.44 on Tuesday. The Nifty tumbled 261.55 points or 1.05 per cent to 24,683.90.

## Apple supplier Foxconn to invest \$1.5 billion in India unit

Apple supplier Foxconn will invest 1.5 billion rupees in its India unit, the company said in a filing, as the iPhone maker shifts more manufacturing out of tariff-hit China.

Foxconn's Singapore-based subsidiary will buy 12.77 billion shares worth 10 rupees apiece, amounting to 127.74 billion rupees (\$1.50 billion) in Yuzhan Technology India, according to the London

Stock Exchange filing.

Yuzhan Technology India, Foxconn's unit in Tamil Nadu, manufactures electronic components and also assembles Apple's iPhones.

Apple is positioning India as an alternative manufacturing base amid U.S. President Donald Trump's tariffs on China, which have raised supply chain concerns and fears of higher iPhone prices, Reu-



ters reported last month.

In March, Apple ramped up India production, exporting around 600 tons of iPhones worth \$2 billion to the U.S.

## Dixon Technologies' Q4 revenue declines over 1.5 pc

**Mumbai:** Consumer electronics manufacturer Dixon Technologies on Tuesday reported a decline of approximately 1.54 per cent in revenue from operations in the fourth quarter (Q4) of FY25, falling to Rs 10,292.54 crore from Rs 10,453.68 crore in the previous quarter (Q3).

Similarly, the total income for Q4 also declined by about 1.49 per cent, coming down to Rs 10,303.82 crore compared to Rs 10,460.18 crore in the prior quarter, according to its stock exchange filing. The company financials showed that some expenses rose, others declined. Finance costs surged by 13.18 per cent to Rs 46.26 crore from Rs 40.87 crore in the previous quarter.

Depreciation and amortisation expenses also increased by around 15.16 per cent, reaching Rs 85.91 crore compared to Rs 74.60 crore in Q3. Other expenses went up slightly by 1.69



per cent, moving from Rs 227.28 crore to Rs 231.13 crore. The total expenses in Q4 decreased by about 1.93 per cent to Rs 9,981.92 crore from Rs 10,178.63 crore in the previous quarter.

However, Dixon Technologies' bottom line showed remarkable improvement. Net profit more than doubled, rising by roughly 115 per cent to Rs 464.95 crore in Q4, up from Rs 216.23 crore in Q3.

#### Tata Power posts Rs 1,306 cr Q4 profit, bets big on Assam with Rs 30,000 cr green energy push

Guwahati: Tata Power has reported a robust Q4FY25 performance, clocking a 25% YoY rise in Profit After Tax (PAT) at ₹1,306 crore, on a revenue of ₹17.328 crore, up 7% YoY. EBITDA surged 14% to ₹3,829 crore. The company recorded its highest-ever annual revenue of ₹64,502 crore in FY25, while PAT before exceptional items rose 26% to ₹5,197 crore—crossing the ₹5,000 crore mark for the first time.

The rooftop solar business continued its dominance with over 1.5 lakh installations and a 3 GW installed base, achieving ₹100 crore PAT in Q4 and ₹209 crore in FY25. The company also reported a ₹4,000+ crore order book for third-party solar EPC projects. Its renewable manufacturing facility in Tamil Nadu produced 3,291 MW of modules and 846 MW of cells. Reinforcing its green energy leadership, Tata Power has

committed ₹30,000 crore to Assam's clean energy projects, signing an MoU to develop up to 5,000 MW. The initiative will also generate 3,000 local iobs.

## **ASCI** releases a whitepaper titled "Examining Opinion Trading in India"

Mumbai: The Advertising Standards Council of India (ASCI) has released a whitepaper titled "Examining Opinion Trading in India,' shedding light on the emerging area of opinion trading/ prediction markets and the need for regulatory clarity

around this rapidly growing sector. As per the National Initiative for Consumer Interest (NICI), these platforms have over 50 million users and transactions exceeding INR 50,000 crore annually. Opinion platforms engage users to make monetary bets

on binary (yes/no) outcomes of real-world events ranging from sports to politics.

Globally, opinion trading is regulated either as a financial instrument or under gambling laws. In India, SEBI has already issued an advisory dated April 29th, 2025, cautioning the public that "... opinion trading does not fall within regulatory purview of SEBI, as what is traded is not security ... ". ASCI has come across advertising from various players, both global and local, as well as influencers on social media

that promote opinion trading as knowledge and skill based games. Ms. Manisha Kapoor, CEO & Secretary General of ASCI, said, "Opinion trading platforms raise serious concerns as their structure and mechanics closely resemble betting

in some instances and can expose consumers to significant financial risk. The advertising that accompanies these platforms often heightens the risk, with exaggerated claims of easy winnings and false assurances of reliability."

## Security deployment for Arunachal's SUMP project triggers protests, raises market concerns

Itanagar: The Indian government's deployment of Central Armed Police Forces (CAPFs) in Arunachal Pradesh's Upper Siang, Siang, and East Siang districts to support the Siang Upper Multipurpose Project (SUMP) has triggered widespread unrest. Three CAPF companies have been stationed at Geku, Uggeng, and Jengging in Upper Siang, with additional forces deployed in Yingkiong, Begging, Parong, Boleng, and

Pasighat to assist the NHPC survey work.

Thousands of locals from Geku, Parong, and Pasighat gathered in Parong village on December 15, 2024, demanding the immediate withdrawal of the paramilitary forces and suspension of the SUMP project. Protesters view the security deployment as an attempt to forcibly impose the controversial dam, raising serious concerns over Indigenous rights and environmental impact. Activists like Ebo Mili condemned the use of force against peaceful indigenous communities, highlighting violations of the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP) and International Labour Organization (ILO) Convention 169. Civil society organizations have appealed to President Droupadi Murmu for intervention. In Itanagar, the unrest

In Itanagar, the unrest threatens the region's socio-economic stability, as local trade heavily depends on peace and community cooperation. Vendors and consumers alike are anxious about disruptions caused by ongoing protests and the heavy security presence, fearing long-term impacts on business and daily life.

The Siang Indigenous Farmer's Forum calls for dialogue and stresses the unconstitutional nature of forced project surveys, urging the government to respect local consent and human rights.

For Q4 FY2025, Medanta reported a 14.1% year-on-year revenue growth to INR 9,542 million, with EBITDA margins improving to 26.0% from 24.7% in the same quarter last year.

New Delhi: Former India captain and current Rajasthan Rovals coach Rahul Dravid believes that true greatness in cricket comes only when players understand themselves deeply-both as athletes and as individuals. Dravid emphasized that natural ability must be complemented by personal growth. "You've been gifted the talent to excel in cricket," he said, "but to unlock your full potential, you must also grow as a person-on and off the field." He warned against the pitfalls of constantly comparing oneself to others, arguing that each athlete's journey is unique. "Your sole task is to harness your own strengths



and work on your individual growth.

Comparing yourself to someone else only distracts from the process of selfimprovement." Drawing on examples from his storied career and his time with the Royals, Dravid urged

young cricketers to cultivate selfawareness through reflection, disciplined routines, and honest feedback. "When you know your strengths and acknowledge your weaknesses, you set a clear roadmap for development," he explained. "That clarity fuels focus, resilience, and ultimately, peak performance." As India's cricketing landscape grows ever more competitive, Dravid's message serves as a reminder that talent alone is not enough. It is the combination of skill, self-knowledge, and continuous personal evolution that separates good players from truly great ones.

#### Rain Washes Out RCB vs KKR, KKR Eliminated



**Bengaluru:** A relentless evening downpour in Bengaluru forced the abandonment of Royal Chal-lengers Bengaluru's clash with Kolkata Knight Riders on Saturday, handing each side a single point and simultaneously nudging RCB closer to a playoff berth while ending KKR's title defence hopes.

The rain, which began around 6 pm and fluctuated in intensity, never relented-so much so that the toss couldn't take place-and officials finally called off the fixture at 10:24 pm. RCB now sit atop the IPL table with 17 points from 12 matches; just one victory in their remaining two games will guarantee them a place in the knockout stage. They currently lead the standings, one point clear of the Gujarat Titans, who have amassed 16 points so far. Next up for Bengaluru is a home encounter with already-eliminated Sunrisers Hyderabad on May 23, followed by an away trip to face Lucknow Super Giants on May 27.

For Kolkata, this washout confirmed a disappointing season: they finish on 11 points from 13 outings and, even with a win in their final league match, cannot reach the fourteam cutoff.

## Gill Stresses Momentum After GT Secure Playoffs

New Delhi: Former champions Guiarat Titans booked their place in the IPL playoffs with a com-manding 10-wicket victory over Delhi Capitals on Sunday, and captain Shubman Gill emphasised the im-portance of maintaining momentum through their remaining league fixtures and into the knockout stage. Opening the run chase of 200, Sai Sudharsan blazed an unbeaten 108 off 61 balls before Gill himself produced a composed 93 not out off 53 deliveries, steering the Titans home with six balls to spare. "Feels great to get the qualification, but we still have two important games left," Gill said at the post-match presentation. "Carrying momentum is important."

Gill explained that he has learned to separate his batting mindset from the added responsibilities of cap-taincy. "I've talked about being a batter first-thinking like one without worrying about captaincy," he said. "Last year I found the leadership role challenging and learned how to manage it late in the season. Our fielding dipped at times and we dropped too many catches, but we reflected on that and worked on it during the break." The enforced hiatus due to the India-Pakistan tensions, Gill revealed, allowed him to recover from an illness. "I'd gotten sick, and that break helped me get back to full fitness," he added. On the field, he praised the chemistry with Sudharsan: "When someone like Sai is in form and convert-



ing starts, things become easier. You don't have to over-communicate—just focus on what's required and stay in the moment."

Assistant coach Parthiv Patel credited the openers' "lowrisk game" and mutual understanding for laying the platform all season. "They know each other's games so well," Patel remarked. "They've worked hard on the basics, and that shows in the way they hit boundar-Under Patel's guidance, ies. the Titans now lead the run charts, with Gill on 609 runs and Sudharsan on 594. Player of the match Sudharsan echoed the mantra of composure. "We stayed cool mentally and targeted a few big overs after the 12th over, which paid off," he said. "I'm more confident now, willing to take the game deeper and expand my repertoireespecially against spin in the later overs." Meanwhile, Delhi skipper Axar Patel highlighted areas for his side to address: "Our batting was excellent, but we need to improve our fielding and powerplay bowling."

With confidence high and momentum firmly in their favour, the Gujarat Titans head into their final two league matches determined to carry this form into the playoffs.

## India Triumph on Penalties to Retain SAFF U-19 Title

(Arunachal Vunia Pradesh): In a pulsating final at the SAFF U-19 Championship, India demon-strated remarkable composure under pressure to beat Bangladesh 4-3 in a penalty shootout, after the match had finished 1-1 in regulation time. The victory ensures that the Blue Colts hold on to their regional crown, much to the delight of a fervent home crowd at the SAI Stadium. From the first whistle, India set the tone. Captain Singamayum Shami sprang a surprise in the second minute with a spectacular free-kick from more than 30 yards. Spotting Bangladesh keeper Md Ismail Hossain Mahin slightly off his line, Shami bent the ball around the wall and into the top corner, leaving

Mahin grasping at air. The early strike electrified the stands and gave India control of the game's tempo.

For the next hour, India dominated possession with crisp passing and sharp offball movement. Wingers Omang Dodum and Rohen Singh repeatedly tested Bangladesh's full-back pairing, while midfield anchors Bibiano Fernandes and Lalengmawia made crucial interceptions. In the 16th minute, Dodum embarked on a mazy solo run that carried him into the box, only for Mahin to produce a vital reflex save to preserve Bangladesh's hopes. Bangladesh weathered the early storm and gradually grew into the contest, carving out their chance in the 61st minute. A chaotic corner kick led to a loose ball in the box, and substitute Md Joy Ahamed was quickest to pounce, drilling a low shot past India's keeper Suraj Singh Aheibam to level the score. It was the first goal India had conceded all tournament, and it shifted the momentum in Bangladesh's favour.

The remainder of regulation saw both sides pressing for a winner, but stout defending and tactical fouls kept the score deadlocked. As the final whistle blew, anticipation turned to nerves in the shootout. India stumbled initially—Rohen's attempt was saved—leaving them 2–3 down. However, when Bangladesh skipper Nazmul Huda Faysal blazed his effort over



the bar, the tide turned. India's five successive suc-cessful kicks, capped by a decisive save from Suraj Singh on Salahuddin Sahed, set the stage for Shami to step up. The captain coolly slotted home the winning penalty, sparking wild celebrations. With this hardfought triumph, India underline their status as the region's pre-eminent youth side, combining flair with unshakeable nerve to secure back-to-back SAFF U-19 titles.
